1. Annual Work Programme (AWP) 2012: priorities supporting RDP implementation

- The National Rural and Fisheries Network and the Network Unit have an overall multi-annual action plan for the years 2007-13. The action plan is followed by annual work sheets which depending on the events can change during the year. Every year priorities are given to one or two themes such as business development, rural tourism, communication of best practice etc. Some activities, as the Annual meetings for board members and managers, are included in the action plan and will be repeated every year. Coordination, information meetings and



training activities are on-going activities. Other activities and events are developed during the year in order to adapt the network activities to the current situation, to the challenges and the emerging needs for local support.

- The Network doesn't have a formal approval date for the annual work programme: in order to have a higher flexibility to react to the territorial needs the programme development is kept as an on-going process. However, each individual activity is formally approved.
- The main priorities for years 2011 and 2012 include business development, job creation and support for the transition to the next programming period.
- The activities implementing the above mentioned priorities are: annual meetings, workshops and presentations, network meetings, thematic seminars, diffusion of best practices, trainings, communication with stakeholders, newsletter and website management.

Issues addressed by working groups:

- Training and workshop activities regarding the preparation of new programmes for the years after 2013.

Issues addressed by committees/steering groups:

- The only formal group is the monitoring committee and the coordination committee establish by the chairmen of the local LAG boards. The monitoring committee has a strong focus on the overall implementation of the programme and the economy. The coordination committee, established by the chairmen of the local LAG boards, deals with administrative and political issues of great importance for LAGs.

Issues subject of surveys/consultation/analysis:

- Several reports /analysis about issues relevant for the new programming period as LEADER added value, the designation of rural areas and the best practices, have been elaborated and are still in preparation.

- Debates on urban and rural development issues and communication stand arranged and hosted by the Ministry of Housing, Urban and Rural affairs during the annual political festival on the island on Bornholm. The event is organized by the NSU.

4. Monitoring and evaluation of networking

- The Network doesn't assess rural network performance through RDP evaluation or through formal evaluation but ad hoc evaluations are run for individual activities.
- Quantitative assessment comparing output units with target indicators are produced. The action plan for the National Rural Network includes some quantitative output indicators for different types or levels of networking:
 - Information, knowledge and capacity building at project level for (potential) beneficiaries,
 - Production and multifunction network, which means activities on specific themes in order to improve business development (new technologies, products, organisations, diversification and multi-functionality, for example seminar on rural tourism
 - Knowledge and capacity building for local action groups (training, seminars, hotline, meetings, newsletter, website, handbooks etc.).
- Qualitative/result-oriented assessment reviewing feedback of network constituents, results and future planned activities of the rural network are discussed with the local partners during meetings.
