Key issues in preparing the ex post evaluation:

- Common understanding between MAs-evaluators (Also on the terminology used)
- Cooperation with stakeholders (Drafting ToR, review and develop EQs)
- Identification of the evaluation needs and scope
- Identification and preparation of the data for evaluation
- How ex post results feed into the new period

Ex post evaluation of 2007-2013 NRNs"



Key issues to include in *ex post* evaluation:

- Network structure
- The relevance of NRN intervention logic (MAs with the support of evaluators and NSU)
- Network's contribution to RDP implementation and objectives
- Network's results and impacts
- Added value:
 - Social Capital
 - Governance
 - Capacity building
 - Unintended effects

Ex post evaluation of 2007-2013 NRNs"



Key issues in implementing the ex post evaluation:

- Take into account the "architecture" of NRNP and RDP NRNs
 - NRN as part of the RDP (Coordination and integration)
 - NRNP as a separate programme (independent evaluation)
- Involve stakeholders in evaluation activities
- Apply robust evaluation method assessment
 Avoid the LEADER evaluation syndrome
 - Use of mixed methods (quantitative + quotauvo)
 - Look for counterfactual

Evaluation of 2014-2020 NRNs



Intervention logic

Difference between the NRN and NRNP intervention logic (IL)

Setting up the hierarchy of objectives:

- First step: construct the IL based on common elements (objectives and groups of actions)
- Second step: Complete the IL with network specific objectives and group of actions in line with the identified needs
- Third step: Identification of the expected outputs, results and impacts

Evaluation of 2014-2020 NRNs



Monitoring and evaluation framework

- It is key to develop the M&E framework together with the IL to avoid future problems (e.g. with data collection)
- There is room to develop network specific indicators by MAs
 - Result indicators
 - Impact indicators??
- It is important to quantify the effects of the NRNs to avoid the LEADER evaluation syndrome → Need for appropriate, quantifiable and realistic indicators. WE NEED TO BE AMBITIOUS!!!


