

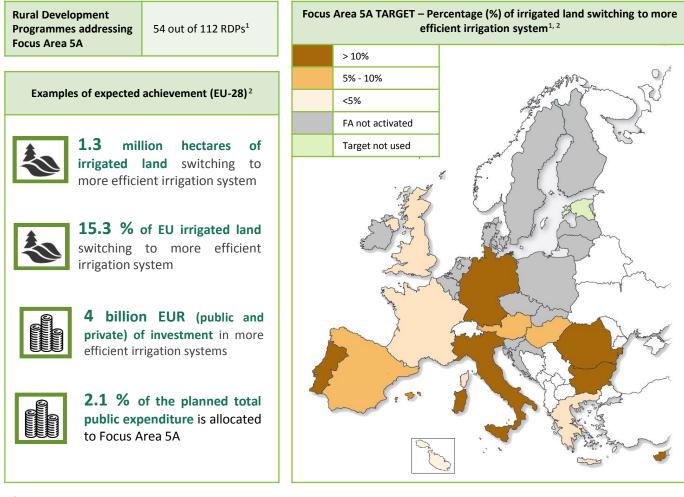
Rural Development Programmes 2014-2020: Key facts & figures FOCUS AREA 5A: Water efficiency

1. Introduction

Focus Area (FA) 5A is designed to increase the efficiency of water use by agriculture.

Most of the support provided is devoted to physical investments in more efficient irrigation systems. These investments are complemented by support for knowledge transfer, training, advise and cooperation.

The target is to mobilise 4 billion EUR of public and private investments to improve irrigations systems in 15% of the EU irrigated land.

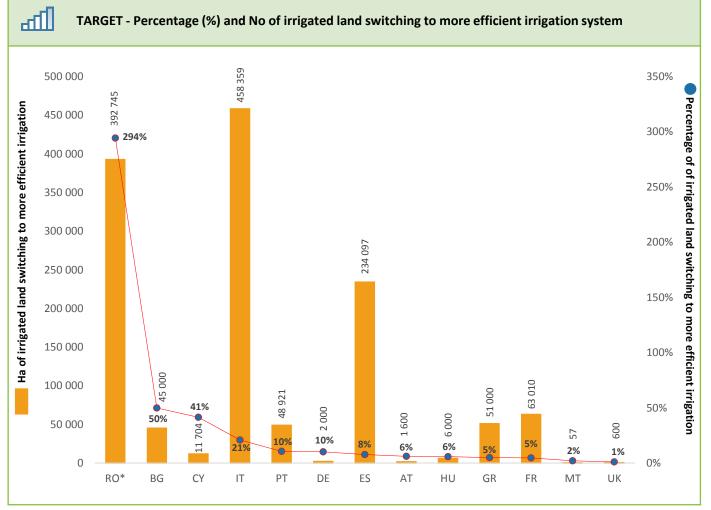

2. Expected achievements

* Romania has large-scale irrigation infrastructure, but significant part is degraded/poorly functional and not actually used (irrigated) in recent years, hence this statistical anomaly.

In addition to the common targets set at EU level, Member States may set programme specific targets which reflect their particular circumstances. Some examples of these indicators are provided below.

Examples of programme-specific target indicators

- ES-Murcia Quantity of water saved thanks to infrastructure investments: 120 000 m3 per year
- RO Percentage of land viable for irrigation switching to more efficient irrigation system: 63.4%

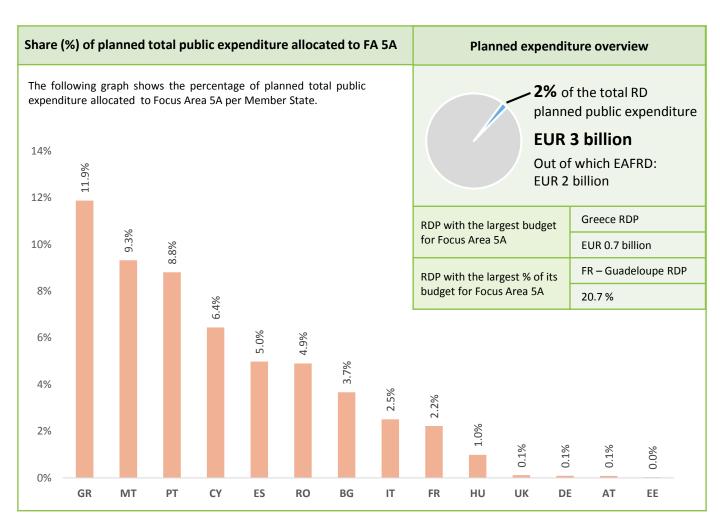

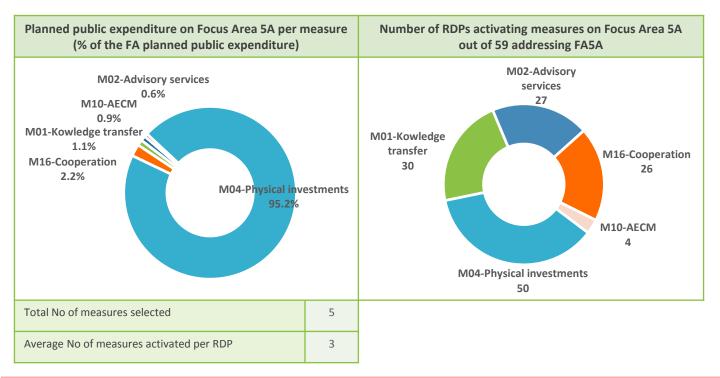
