



Background

Good data availability and data quality is essential for evidence-based assessment of the programme effects. Adequate data should be collected for applying robust evaluation methods able to identify net effects and to properly evaluate Rural Development policy interventions. In the programming period 2014-2020, targeted data management has gained in importance. As stated in Art. 66(1) of Reg. 1305/2013, Member States must ensure the existence of a statistical information system with indicators that are necessary for undertaking evaluations.

Monitoring systems should be systematically prepared for later evaluation purposes and at the same time a good cooperation between data providers (i.e. Paying Agencies, statistical offices, etc.) and data users (Managing Authorities, LAGs and evaluators) needs to be ensured.

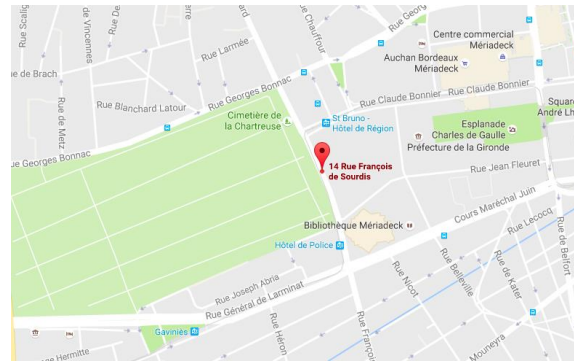
Targeted data management implies to:

- > set up a system to collect beneficiary-data, non- beneficiary data and contextual data, and create the basis for reliable control groups
- > collect, process and store monitoring data in line with CMES requirements
- > organise inter-institutional cooperation in order to collect data in time and to provide timely and meaningful data to evaluators.
