#### 1. Introduction

Support under this measure is granted to:


- help farmers, young farmers, forest holders, other land managers and SMEs in rural areas to benefit from the use of advisory services;
- b) promote the setting up of farm management, farm relief and farm advisory services, as well as forestry advisory services, including the Farm Advisory System;
- c) promote the training of advisors.

There are 3 sub-measures that support a wide range of operations for advisory services. Section 5 outlines the No. of Programmes activating each sub-Measure.

This section provides information on the overall expected achievement for the Measure, in terms of outputs and planned expenditure.









### 3. Measure's planned public expenditure per priority and Focus Area

This section shows the percentage of the total public expenditure allocated to Measure 2 per priority and Focus Area at EU 28 level. Priority 1 is considered a crosscutting priority, therefore the planned expenditures under Priorities 2 to 6 will contribute to the achievements of Priority 1 specific targets.



### 2. Total planned public expenditure per Member State

The following chart shows the planned total public expenditure for Measure 2 per Member State. For Member States with regional programmes the national budget allocation for the measure is calculated as sum of the regional RDPs. The chart also illustrates the planned total public expenditure for Measure 2 as percentage (%) of the overall planned total public expenditure at Member State level.

Out of the 118 Rural Development Programmes only the 112 national and regional Programmes have been considered because National Frameworks and National Rural Network Programmes do not allocate budget on Measures. Please note that data and calculations provided do not include M20 (Technical Assistance), or M18 (Complementary payments to Croatia).
