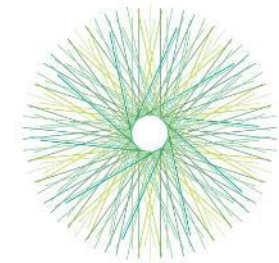

State of play RDP approval and EIP-AGRI programming



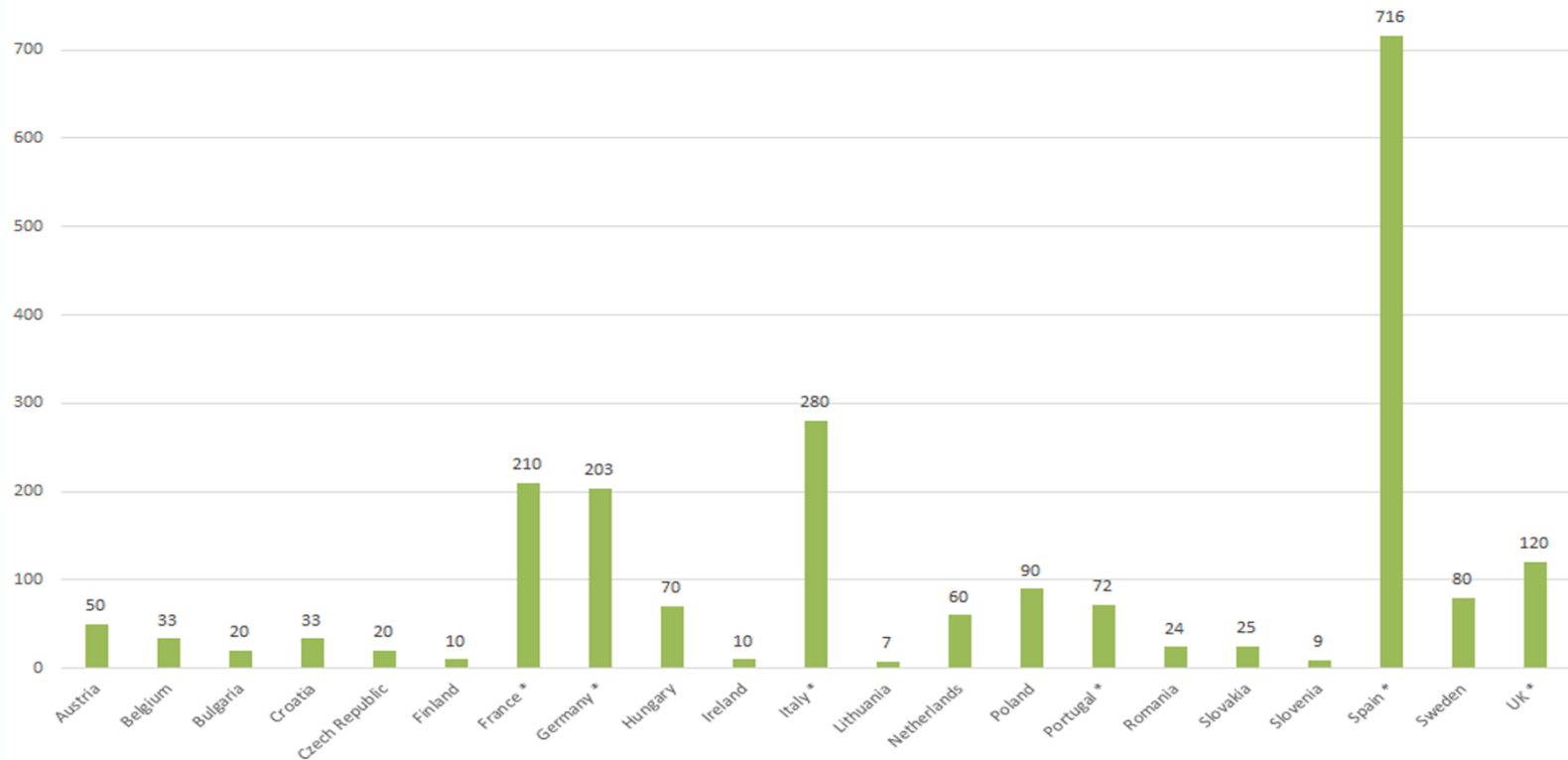
State of play (as of 30/09/2015)

- **87 out of 118 Programmes approved** (81.8% of the RD budget, approved in 25 MSs, completed in 22 MSs)
- The sub-measure "establishment and operation of operational groups of the EIP" is foreseen in about **90 National and Regional RDPs (in 23 MS)** out of a total number of 118 RDPs.
- **First OG projects have been selected** and some started in June (in Schleswig Holstein – Germany).

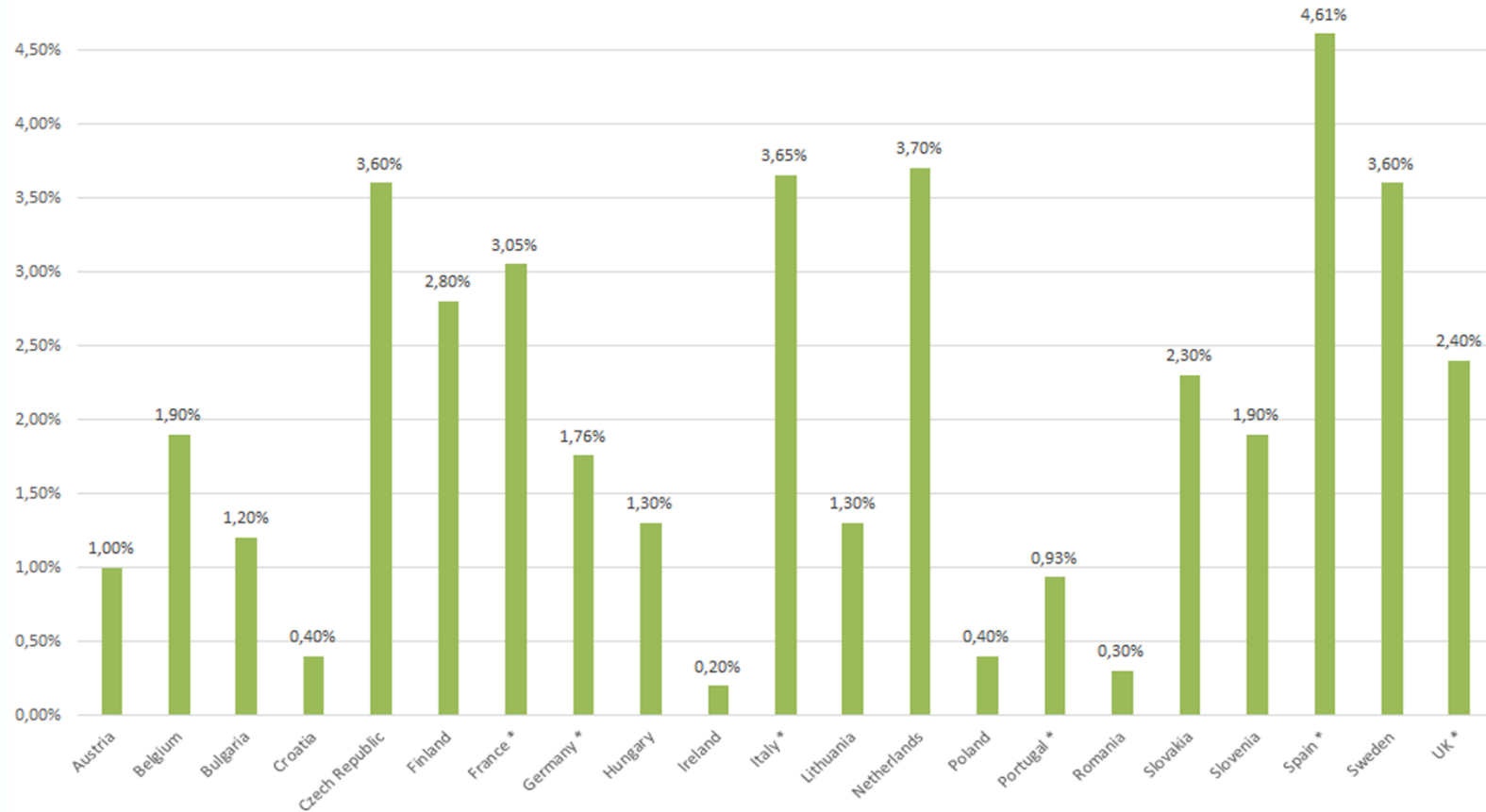

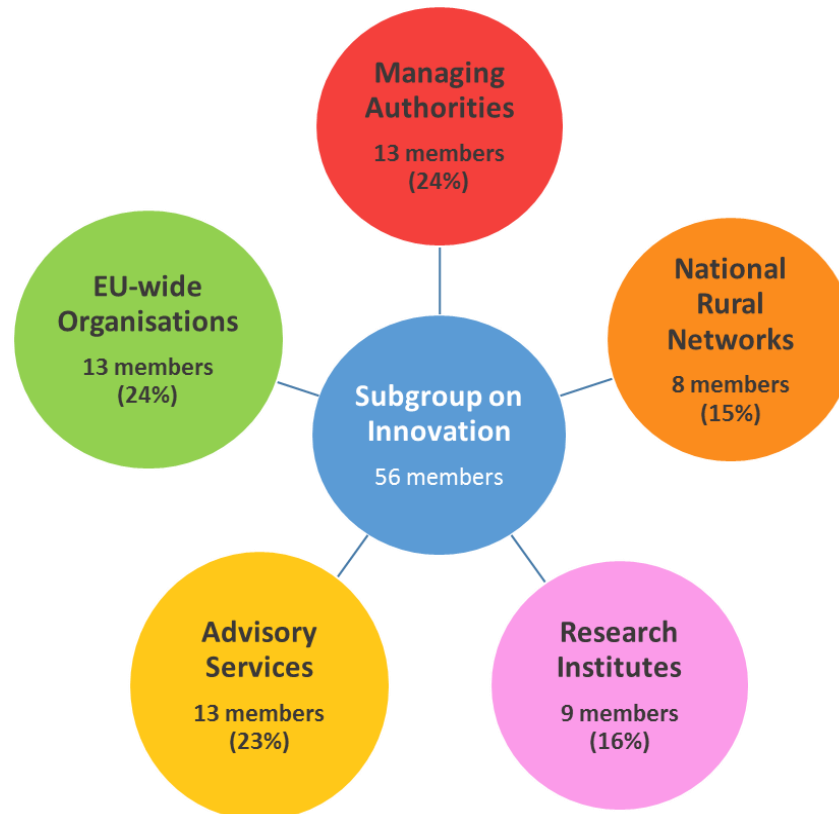

- ***"Operational Groups"*** are no stakeholder networks, no stakeholder boards, no thematic coordination groups, nor discussion groups
- ***"Operational Group"*** = a team composed of those actors relevant for the project, working together in an innovation project and producing concrete results

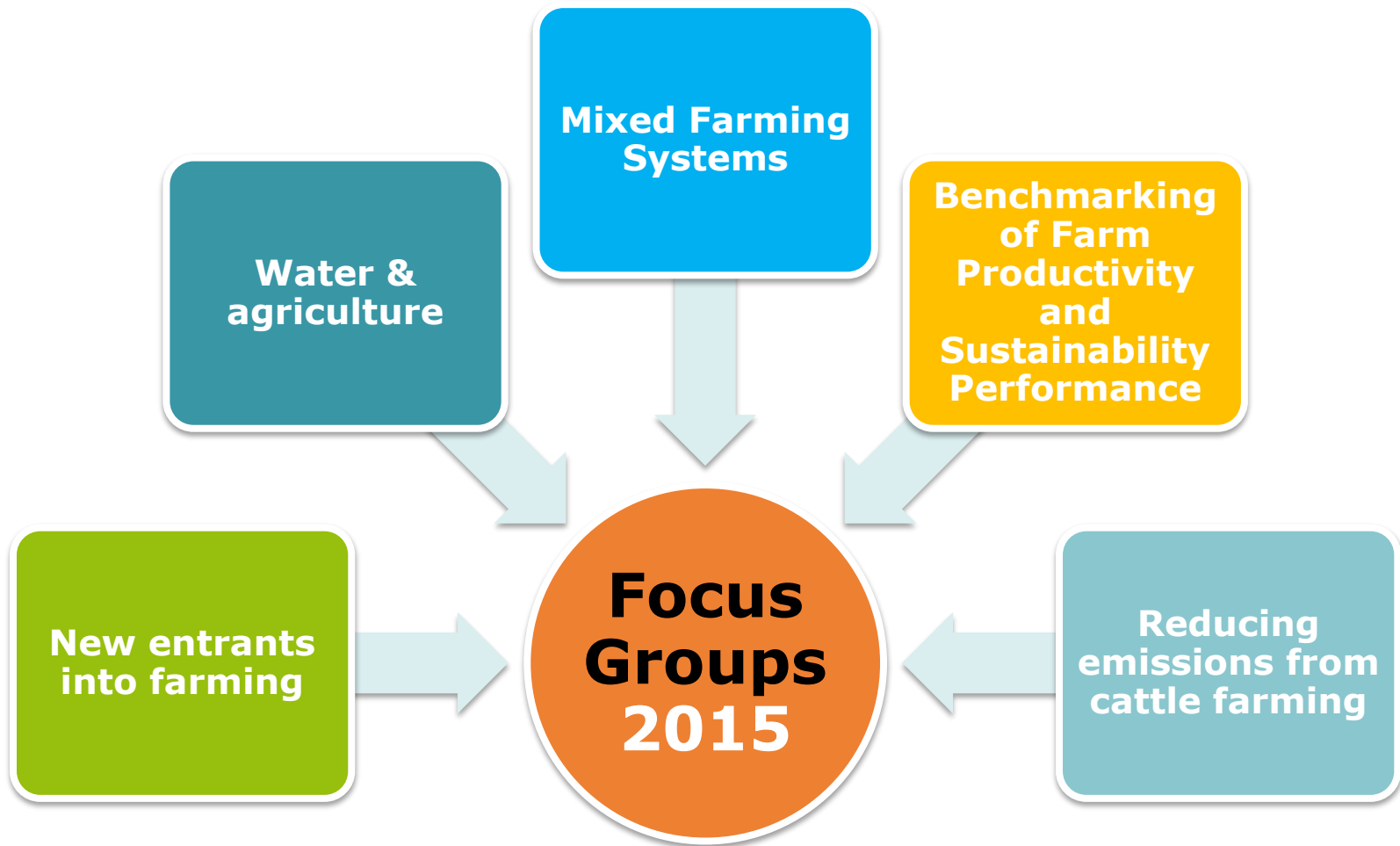

EIP networking at national / regional level

Main objectives for NRNs 2014-2020

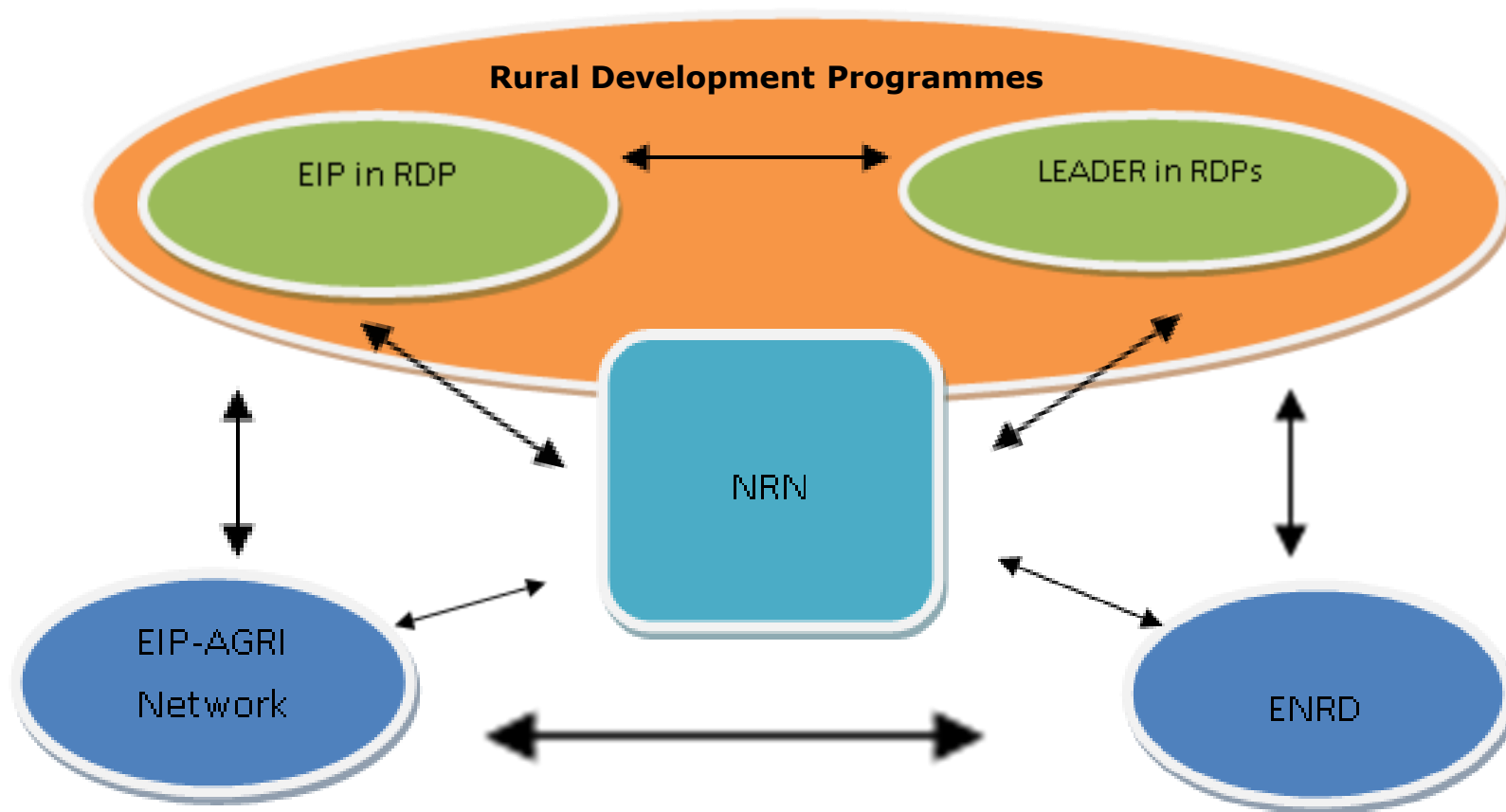
- *Increase the involvement of stakeholders in the implementation of rural development*
- *Improve the quality of implementation of RDPs*
- *Inform the broader public and potential beneficiaries on rural development policy and funding opportunities*
- ***Foster innovation in agriculture, food production, forestry and rural areas***



NRN Action Plan

- *Art 54(3) of RDR 1305/2013 sets out as a strategic task for NRNs to envisage*
- ***networking for advisors and innovation support services***
- *and the search of partners*
- *The **action plan of NRN** should cover at least*
 - ***the search of partners*** for the cooperation measure (Art.35)
 - ***provide networking for advisors and innovation support services.*** Article 54(2)(d) and Article 54(3)(b)(iii) and (iv)

Links



Contribution of NRNs to the implementation of EIP-AGRI and its network

- *Awareness raising: organising meetings, WSs, acting as **multipliers***
- ***Networking** at national / regional level of rural development innovation actors – **Operational Groups***
- *Provision of **information about***
 - *RDP measures and actions targeting innovation and knowledge transfer*
 - *Examples of projects and good practices*



Contribution of NRNs to the implementation of EIP-AGRI and its network (cont.)

- ***Cross-border exchange of information*** about projects, research initiatives, Thematic Networks, funding possibilities e.g. H2020
- ***Acting as or supporting Innovation Support Services (ISS)*** for animating innovative actions and establishing OGs at the national level
- ***NRNs active role in setting up OGs by***
 - **collecting information,**
 - **animating bottom-up initiatives,**
 - **helping to refine innovative ideas**
 - **providing support for finding partners and funding**

- **No obligation** for the MS to create a specialised innovation network or Support Unit, the role can be assumed by the NRN
 - *situation in MSs and regions? – Mapping exercise in the WS*
- NSUs should foresee **capacity to work with all innovation actors and networks**
