Mission Statement and Strategic Objectives of the Rural Network

- The NRN is defined as "the arena for mutual cooperation and learning" and its main purpose is to reinforce the implementation of the Swedish Rural Development Programme (RDP) 2007–2013.
- The main tasks of the Swedish network include:
 - to support the exchange of information and methods;
 - to reinforce national actors' dialogue with local and regional actors involved in the implementation of the RDPs;
 - to support cooperation Activities with other countries;
 - to strengthen links between rural, regional and environmental policy.

Participants in the Rural Network

- The network is characterized by an on-going formal membership without membership fee.
- The network membership is open to public sector and stakeholder organizations but not to individuals.

Network Structure

- The Network Support Unit (NSU) is not established within the Managing Authority and is not outsourced but is delegated to a ministerial agency: the formal membership-based network has a secretariat, the National Network Unit (NNU), located within the Swedish Board of Agriculture.
