
Reminder on the objective and organisation of the EN RD

#### **Objectives:**

- To support the development of «know-how » of the rural networks
- To increase the efficiency of the exchanges between them

#### Activities:

- a) Needs enquiries (questionnaires, meetings)
- b) A specific seminar on capacity building
- c) Preparation of support to Transnational Cooperation (Leader)

#### mapping the state of play



#### Needs assessment:

Survey of national rural networks in Feb-March 2009

- Aims:
  - mapping the situation
  - identifying the needs/bottlenecks/challenges

#### Follow-up:

- First results presented on 30-31 March seminar
- <u>Strategy paper</u> outlining the information needs and method of exchange between EN RD/NRNs/other networks (May 2009)
- NRN fiches <u>compendium</u> as an on-going tool (web-page)



## 2.a) Meetings CP/NRNs



#### Meetings between Contact Point/NRNs:

- 27 november 2008 (Brussels): kick-off meeting
- 13 Feb 2009 (Prague): involvement of stakeholders
- 1 April (Brussels): capacity building
- 29 April 2009 (Brussels): first discussion on good practices / relevant experiences in implementation of RDP
- To come: 8 June 2009 (Sevilla): cooperation

## 2.b) Seminar "Capacity building for NRNs" 30/31 Marc



#### **Participants:**

• NRNs, regional rural networks, Managing Authorities, organisations, LAGs, Contact Point, the Commission

#### **Objectives:**

- Identification of the challenges of NRNs
- Understanding of mutual expectations
- interlinks between networks

#### Some outcomes:

- Better perception of expectations (even if diverse), more ideas
- Need for strategic approach highlighted
- Need to further develop links between different levels and actors
- => Need for continued activities on capacity building



# 2.c) Support to transnational cooperation (TNC) for Leader



#### First activities carried out:

- Needs assessment of NRNs and of LAGs on TNC
- questionnaire to Managing Authorities presented to RDC on 22/04

#### Follow-up:

- Development of useful information on-line to support TNC
- Possible development of the administrative "Guide for implementation of measure cooperation" for MAs (if needed)
- Preparation for setting up different databases (Partner Search Tool, LAGs database, projects under approval, approved projects)

Objective: To work on key topics of common interests and for concrete results

#### In the first year:

- a) Launch of 3 thematic working groups
- b) 2 screenings of programmes and compendia
- c) Other activities: monitoring indicators; good practices / interesting cases and preparation of seminars



# 3.a) Creation of the first thematic working groups



#### Theme 1: Targeting territorial specificities and needs in RD programmes (pre-meeting on 11 March)

(An efficient targeting of territorial specificities and needs in RD programmes and a more balanced development of rural areas across Europe)

#### <u>Theme 2: Agriculture and the wider rural economy (pre-meeting on 10</u> March)

(Identification and description of the relationships and potential synergies/conflicts between, on the one hand, agriculture and, on the other hand, the wider rural economy).

#### Theme 3: Public goods and public intervention (pre-meeting on 24) April)

(How RD interventions can enhance the provision of public goods for the benefit of society).

# 3.a) Creation of the first thematic working groups

(continued)

- Small groups: from 10 to 11 members each
- Timeframe (indicative):
  - First steps: ~ mid-summer 2009
  - ➢ Second meetings: End June or Autum 2009
  - Intermediary results: beginning of 2010
  - ➢ Possible seminar: second half 2010
  - ≻ Final deliverables: end 2010.



# 3.b) Some compendia



- 2 compendia related to RDPs currently developed:
- Fiches by RDP's on how the programmes address the Climate Change challenges (mitigation, adaptation and renewable energy).
- General fiches to present the RDPs in a synthetic way.



**3.c) Other thematic and analytical activities** 



- Second checks of the 2007 APR's monitoring indicators
- Preparation of the collection of relevant experiences (good practices) for each Axis of the RD policy
- Preparation of a seminar on « semi-subsistence farms » - target date: April 2010
