#### Main objectives and field of activities



#### Main objective: efficient RD policy / increased dialogue

Capacity building: development of the rural networks

Thematic and analytical analysis: joint work on common concerns

*Communication tools: efficient support for activities / useful information to stakeholders*

### <u>1- Coordination at EU level:</u> importance of role of CC and LsC

<u>Ongoing</u>: meetings twice a year <u>In preparation</u>: extranet facility for regular exchanges

<u>New</u>: towards a more operational role of CC and LsC? More exchanges inbetween meetings?





#### a) Support to rural networks 2009-2010



2- Support to the National Rural Networks: capacity building as an ongoing process

<u>Ongoing</u>: meetings between CP-NRNs; needs assessments; circulation of information; on-the-spot visits

<u>In preparation</u>: joint work on collection of 'relevant experiences' (/ good practices)

New suggestions:

- a follow-up seminar on capacity building?
- setting-up tasks forces or focus groups to tackle specific issues? grouping NRNs in specific partnerships?
- organising trainings / practical workshops?
  - circulation of information between networks?





#### a) Support to rural networks 2009-2010



<u>3- Specific support to LAGs and Transnational cooperation</u> (TNC): addressing the challenge of mainstreaming Leader

- In preparation: development of on-line information and databases (LAGs, partner search tool for TNC, etc.) New suggestions:
- For Leader: creation of focus groups on specific key issues; circulating information on evaluation (input from EEN)?...
- For TNC: cooperation fair; Training or practical workshops; Development of E-learning ?

4- Cooperation between all stakeholders, beyond Leader Rural Development view to promote cooperation for rural development? Coordination committee meeting 19/05/2009 12





- <u>1- Thematic working groups (TWG):</u> jointly investigating key strategic issues
  - Ongoing: 3 TWG on:
    - « targeting territorial specificities and needs »,
    - « links between agriculture and the wider rural economy»,
    - « Public goods ».
  - In preparation:
  - communication plan for existing groups
  - <u>New:</u>
    - kick-off of new groups which thematic priorities?







2- Complementary analysis of rural development programmes (RDP) and monitoring indicators: getting essential background information

In preparation:

- set of summaries of RDPs in a compendium
- screening of RDPs as regards 'Climate change mitigation and adaptation' (and for TWGs)
- analysis of databases of monitoring indicators

<u>New:</u>

- further 'screenings' exercice to improve the information base on specific topics?

- <u>3- Thematic events</u>: discussing and exchanging on common concerns
  - Provisional:
  - seminar on semi-subsistance farming (spring 2010)
  - initiate preparation of seminar(s) related to the TWGs (second half 2010)
  - New suggestions:
  - Broadband?
  - climate change?







- <u>4- Identification of relevant examples (/good practices):</u> learning from others
  - In preparation:
  - methodology being developed in consultation with NRNs

#### New suggestions:

- clarifying a collection and dissemination plan
- early launch of a pilot application?
- creation of a database?







- 5- Interacting with the Evaluation Network and disseminating results of research: going further into analysis – increasing knowledge
  - Ongoing:
    - regular exchanges of information between networks

New suggestions:

- reinforced collaboration in the approach to mid-term evaluation;
- guidance on evaluation of networking activities?





# c) Communication tools 2009-2010



<u>1- The web site :</u> the core information and communication tool of the ENRD

<u>Ongoing</u>: opening of first static pages <u>In preparation</u>: interactive parts / extranet to create specific platforms of exchanges <u>New development</u>: ongoing – possible at all time

2- Publications: developing and circulating useful information

<u>Ongoing</u>: newsletters / periodicals <u>In preparation</u>: posting on website with multiple access



New development: towards more electronic formats

3- Promotion and representation of the EN RD: going local

Ongoing: participation in various fairs / events


<u>New</u>: towards more synergies with other events (e.g. EU calendar of events). New support material?

4- Information line and reception of visitors

Ongoing: answer to questions / provision of information

<u>New development</u>: enhanced information provision regarding specific topics (e.g. funding opportunities, sources of expertise...)?
