General information about LEADER in Bulgaria

Managing Authority – Ministry of Agriculture and Food/Rural Development Directorate

<u>Main responsibilities:</u> Developing the legal framework related to the implementation of measures under Axis 4 LEADER of the RDP; approval of the Local Development Strategies and Local Action Groups; control and monitoring of implementation of Axis 4.

Paying Agency – State Fund Agriculture

Main responsibilities: Approval and authorization of all payments under Axis 4 of RDP.

Local Action Groups

<u>Main responsibilities:</u> Development and implementation of Local Development Strategies; pre-selection of the projects for funding from the LDS; implementation of the promotional activities, publicity, support beneficiaries, etc.



General information about LEADER in Bulgaria

Total budget allocated for LADER approach in Bulgaria – 77 mln. €

Budget breakdown by measures:

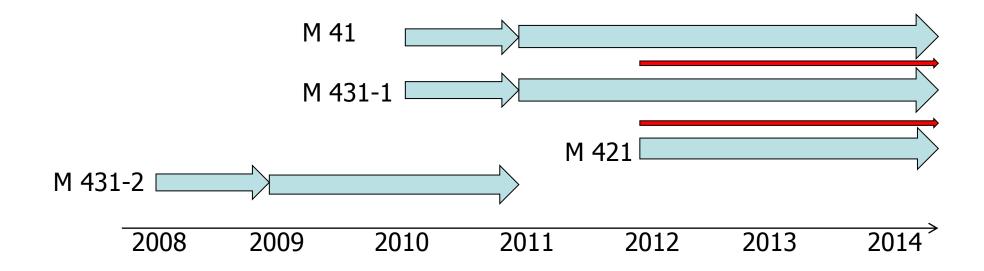
M 41 Implementation of the local development strategies – 54 mln. €

M 421 Inter-territorial and trans-national cooperation – 5 mln. €

M 431 Running costs, acquisition of skills and animation – 18 mln. €

Preparatory support 2007 - 2013

Why?

- New approach unknown for the communities in the rural areas
- Absence of information and skills of potential beneficiaries concerning LEADER implementation
- Absence of administrative capacity at local level for implementation of LEADER
- Absence of resources to support LEADER start-up (stuff, offices, equipment, etc.)

Results?

- ✓ Increased awareness in 60 % of the local communities in the rural areas about the possibilities, which the LEADER approach provides;
- ✓ Trained 11 446 people;
- \checkmark 90 potential LAGs offices equipped and staff trained.



Preparatory support 2007 - 2013

Interest in implementation of Sub-measure 431-2:

Number of applications received: 136

Number of Municipalities in the Rural Areas included in the potential LAGs submitted the applications: **181** (78% of the Municipalities in the Rural Areas)

Number of Municipalities in the Rural Areas included in the approved potential LAGs: **157** (68% of the Municipalities in the Rural Areas)

Number of Municipalities in the Rural Areas successfully implemented their projects: **137** (60% of the Municipalities in the Rural Areas)

Total covered area: > 64 000 sq. km.

Total covered population > 2.2 mln people



Implementation of Measure 41 and Sub-Measure 431-1

To calls for applications for financing under measure 41 "Implementation of the Strategies for local development" and sub- measure 431-1 " Administration of the LAG, acquirement of skills and receiving social activity"

First – January – August 2010

- 55 applications were received, 50 out of them were submitted by beneficiaries under Sub-Measure 431-2.
- 16 LAGS were approved with a total budget of 31,5 mln. €.
- 14 LAGs were beneficiaries of Sub-Measure 431-2.

Second – October – November 2011

- 71 applications were received, 68 out of them were submitted by beneficiaries under Sub-Measure 431-2.

- 19 LAGs were approved with a total budget of 34,2mln. €.
- All the 19 approved LAGs have been beneficiaries under Sub-Measure 431-2.

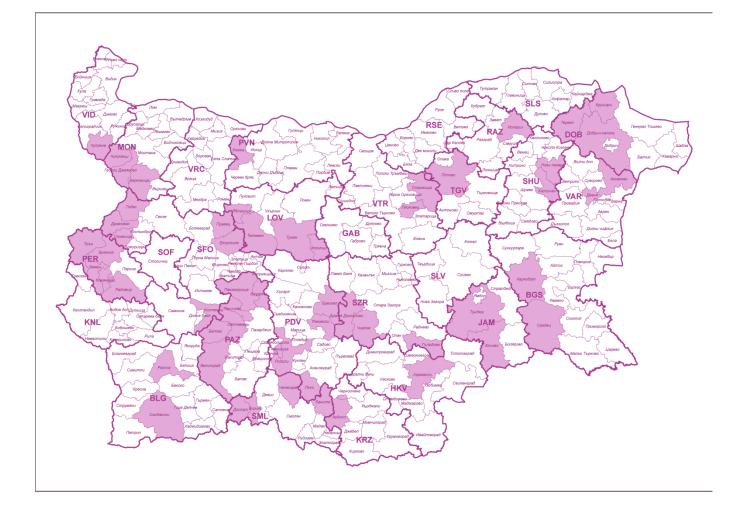


Implementation of Measure 41 and Sub-Measure 431-1

- 1. Total approved LAG 35;
- 2. Total amount of the contracted and absorbed budget 70 mln. \in (98 % from the budgets of the measures 41 and 431);
- 3. Total covered area by the LEADER approach $-25\,800$ square km. -23% of the country and 29% of the rural areas;
- 4. Total population covered by LEADER approach over 800 000 people;
- 5. Total number of municipalities in rural areas 57.

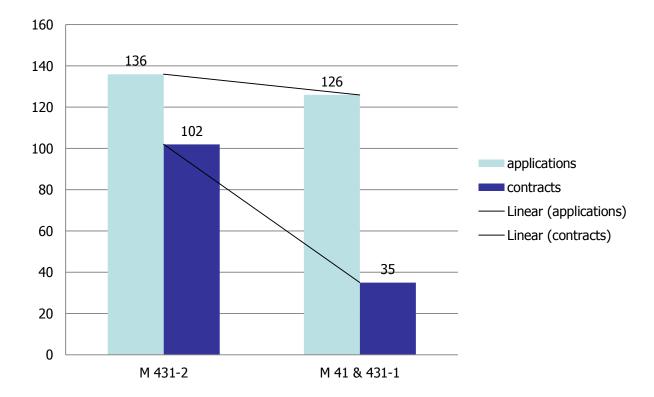


Implementation of Measure 41 and Sub-Measure 431-1





Bottleneck effect





Bottleneck effect

Reasons?

- \checkmark Limited budget
- \checkmark LAGs mainly are formed by one (18 LAGs) and 2 (12 LAGs) municipalities

Negative effects:

- \checkmark Weak sustainability of the results achieved under preparatory measure
- \checkmark Less covered area and population
- \checkmark Disappointment of communities without financing of LDS



Measure 421 "Interterritorial and transnational cooperation"

Three calls for proposals: 34 applications were received estimated at 2,5 mln. €

Approved: 22

Contracted: 12 (5 contracts to be signed)

Crucial points:

- Very useful tool for development of the local communities
- Registered high level of interest by LAGs
- Difficulties in implementation due to different administrative procedures in the different countries
- Complicated administrative procedures at national level
- _ The interest decreased as LAGs experienced the administrative troubles
- **_** Some of the approved applications were canceled by the beneficiaries



Conclusions by stages of implementation

At the beginning:

- difficulties with persuasion of the local people in LEADER positive effect;
- lack of administrative capacity in local communities to implement LEADER.

During the implementation:

- Successful implementation of LEADER depends on the smooth interaction between all organizations included: Managing Authority, Paying Agency, Local Action Groups, Local people. Any fluctuation in the cooperation between the stakeholders has negative effect on the overall implementation.
- Too complicated administrative procedures are inconsistent with the LEADER spirit.

Conclusion:

LEADER aroused great interest amongst the local communities and they recognized it as an instrument for development of their territories.



Community-Led Local Development 2014 - 2020

How to get better than 2007 – 2013 and to avoid negative effects?

Separate measure 19 of the RDP

Four Sub-Measures:

19.1 Support for preparatory activities

19.2 Implementation of operations under CLLD LDS

- 19.3 Support for transnational and interterritorial co-operation activities
- 19.4 Running costs and animation



Preparatory support

WHY?

- ✓ Preparatory support is essential for the actual implementation of LEADER in a streamlined and optimized manner (bottlenecks, weak points, risks, etc. could be detected at early stage and overcame)
- Preparatory support activities encourage and motivate local communities
- ✓ Preparatory support allows all communities (even those not familiar with LEADER) to benefit from LEADER

WHAT IS NEW?

- \checkmark Duration 6 12 months
- Minimum project amount EUR 10 000
- Maximum project amount EUR 40 000



Implementation of operations under LDS

- ✓ Increased budget 129 mln. \in (50 mln. \in more)
- ✓ Encouraging LAGs to be formed by more than one municipality
 ✓ < 15 000 inhabitants up to 1 mln. €
 ✓ > 15 000 inhabitants up to 2 mln. €
- \checkmark Simplification of the administrative procedures
- \checkmark Shortening the periods of selection of LAGs
- ✓ Providing opportunity LAGs to benefit from different funds: EAFRD, ESF, EFRR, EMFF
- \checkmark Providing maximum time for implementation of LDS



Transnational and inter-territorial co-operation activities

- ✓ Increased budget 7,5 mln. \in (2,5 mln. \in more)
- \checkmark Ensuring of sustainability of the results achieved in 2007 2013 period
- \checkmark Simplification of the administrative procedures
- Supporting innovative projects with high added value to the local communities

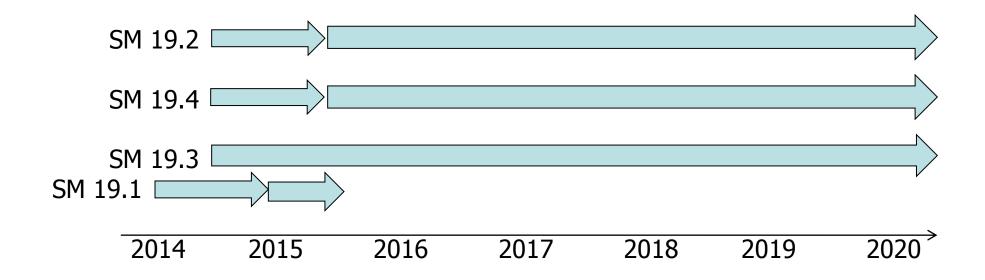


Running costs and promoting the CLLD LDS

- Increased share of the running costs up to 25% of the LDS
- Advance payment up to 50%
- Providing more flexibility and independency for LAGs to operate
- Cost effective control



Timetable of implementation of CLLD in Bulgaria





GOALS

- ✓ Wider coverage of the communities in the rural areas at least double than for the period 2007 – 2013
- ✓ Higher number of approved LAGs 60
- \checkmark Achieving greater impact of CLLD implementation for the rural areas
