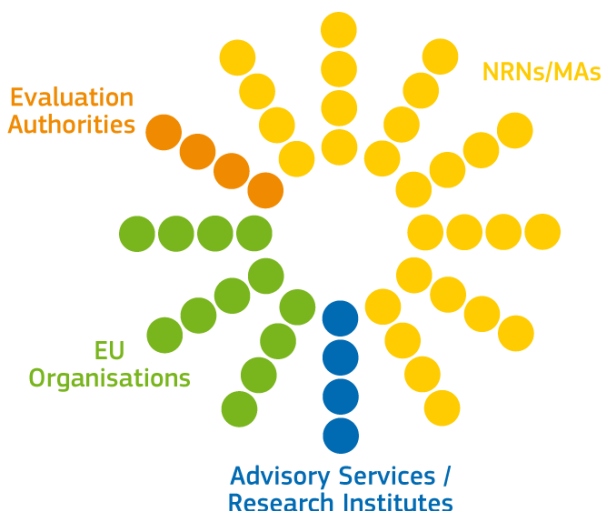


## European Rural Networks' Steering Group
