Rural Development in Denmark is managed nationally through **one Rural Development Programme** (RDP), funded under the [European Agricultural Fund for Rural Development](#) [1] (EAFRD) and national contributions. The RDP sets out priority approaches and actions to meet the needs of the specific geographical area it covers.

Rural development funding through the EAFRD is part of a broader framework of [European Structural and Investment Funds](#) [4] (ESI Funds), including also Regional Development, Social, Cohesion, and Fisheries Funds. These are managed nationally, by each EU Member State, on the basis of **Partnership Agreements**, strategic plans outlining the country's goals and investment priorities.
