### Module C: Evaluation of LEADER/CLLD

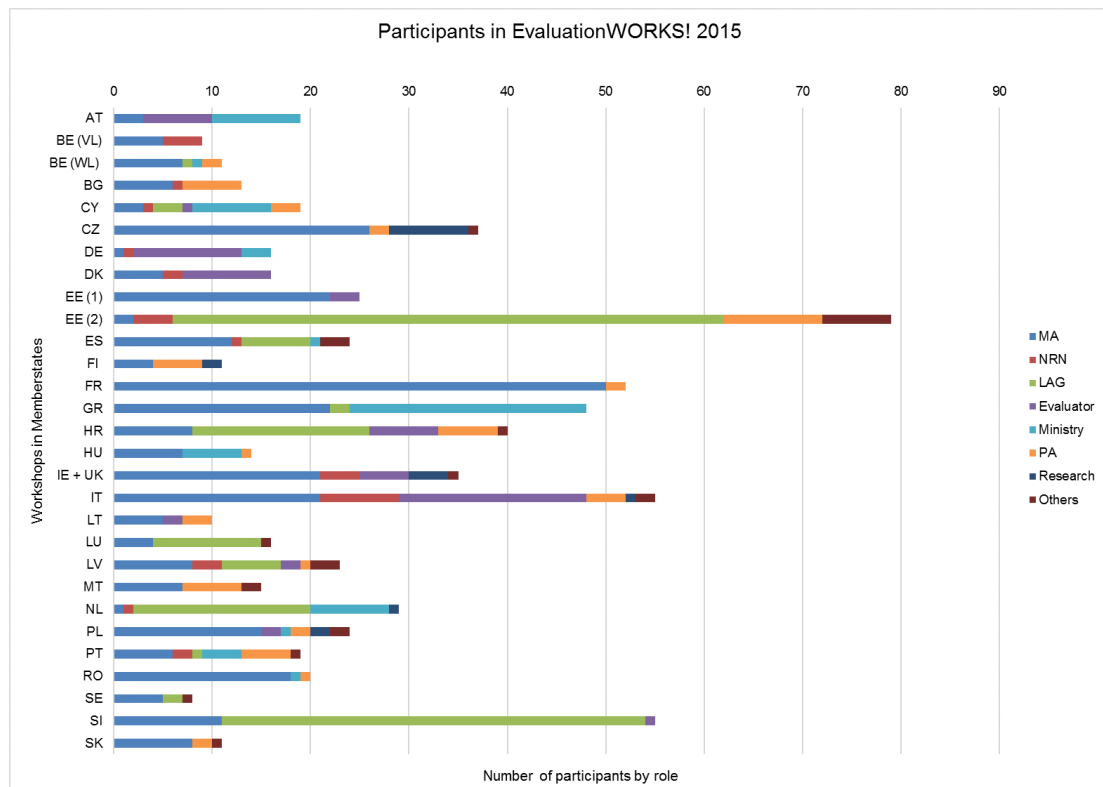
- Requirements on the evaluation of LEADER (at RDP and LAG level)
