- The umbrella organization of associations, cooperatives, family farms, businesses and trade in agriculture.
- 75000 family farms.
- Full member of the of the Copa, Cogeca, Geopa, WFO.
- The only organization of agricultural producers participating in the work of nearly 30 committees, councils and other government bodies and municipalities.

WHAT THE CCA DOES FOR FARMERS?

- **Represent their interests** (access to preparatory documents of the European Commission and the European Parliament, finding and articulating best possible solutions).
- **Keep them informed** (regular information about current events in agriculture, negotiations and competitions on a national and international level.
- Educate and organise the events (organising professional visits abroad and domestically, organising roundtable discussions, conferences and lectures (making promotional and financial plans, selection of lecturers).
