1st Set of measures

Improvement of governance

Supporting central, regional and local Administrations in the improvement of rural development programmes' performance, in terms of efficiency, efficacy and integration with other policies.

Encouraging the connection of national, regional and local Institutions with horizontal and vertical partnership in the implementation of rural development policies and their coordination with other policies.

- **1.1.1** Horizontal support to Administrations engaged in the Rural Development Programme implementation
- **1.1.2** Support to the establishment of the national monitoring and evaluation system

Strengthening of the managerial and planning capacities

Supporting the acquisition, updating and improvement of managerial and planning capacities of individuals involved in the implementation of Rural Development Programmes, also with a view to integration and coordination with the other policies.




BEST OF ITALIAN NATIONAL RURAL NETWORK 2007. 2013


NRN to support RDP implementation

- EU Questionnaire on the perception of rural areas by young people → promoted by Italy NRN with the involvement of 8 NRNs.
- VIDEOFARMERS
- Cooperation Italy-NRN & European Network for Evaluation (sharing the organization of workshop and focus group in Rome 21st October 2008 8th November 2012, 17th October 2013, 10th-11th April 2014; support in the definition of thematic evaluation guidelines; study visit with Portuguese, Greek, and Swedish representatives)
- PIKSE (Project Information and Knowledge Sharing Experience methodology for the collection of good practices at EU level).
- Focus Group Knowledge Transfer & Innovation (and other FGs)
- Participation to Video Project "YOUNG FARMERS" with 7 NRNs.

Suggestion to ENRD 2014-2020 for future work



- ✓ To continue with a thematic approach in the activities (no generalist approach)
- ✓ To better involve the MA managers and Rural Stakeholders in the activities as participants (ENRD more connected with the grassroots level needs)
- ✓ "Learning by doing" and increasing of "peer to peer" activities in order improve RDP implementation in the EU transfer of good practices
- ✓ European methodology for the classification of good practices (capitalizing PIKSE experience)
- ✓ Training for NSU (animation, web tools, management of the programme, more accountability, involvement of stakeholders)
