Background and objectives

The Seminar is part of the ENRD integrated work package on 'improving RDP implementation' whose main objective is to 'provide those directly and indirectly involved in RDP implementation with knowledge and tools in order to address key challenges and improve the quality of RDP implementation from the outset of the 2014-2020 programming period'.

At a time when the majority of the 2014-2020 RDPs are adopted or next to be, the seminar focuses on the next steps that RDP authorities will need to take to lay down the operational framework for the implementation of programmes. National and regional rules and provisions will be rolled out determining among others, requirements and selection criteria that will translate strategies and priorities into concrete interventions. Crucially, the partnership will need to be consulted to ensure that decisions made in this respect reflect programming needs.

In this framework, the seminar aims at bringing together national and regional MAs and other stakeholders concerned with the implementation of RDPs to identify main challenges for the successful start of RDPs, opportunities for improving RDP implementation and joint actions to be carried out at the EU level.

At the operational level, the seminar aims at:

- Sharing experiences about methods and approaches to RDP implementation which address recognised weaknesses and embrace new opportunities and learn from them
- Raise awareness of administrative and/or practical constraints to implementation and highlight needs for further action
- Contribute to the creation of a "community of practice" at the EU level involving those responsible for designing and implementing RDPs.
